RELEASE OF TRADEMARKS

Release of Trademarks (the "Release"), dated as of July 30, 1999, made by The First National Bank of Chicago, as Collateral Agent ("Collateral Agent"), in favor of Crosman Corporation, Voit Sports, Inc., Bushnell Corporation, Voit Corporation and Benjamin Sheridan Corporation (collectively, the "Pledgors").

R E C I T A L S :

A. The Pledgors and Collateral Agent entered into a certain Intellectual Property Pledge Agreement, dated as of April 27, 1995 and recorded as to Trademarks in the United States Patent and Trademark Office on May 3, 1995 in Reel 1352 at page 387 (the "Agreement"; capitalized terms used herein and not defined shall have the meanings set forth in the Agreement), pursuant to which the Pledgors granted to Collateral Agent a lien on and security interest in certain Pledged Collateral owned by the Pledgors.

B. In accordance with the terms of the Agreement, the Pledgors have satisfied all of their outstanding obligations under the Agreement, and in connection therewith, the Pledgors have requested and Collateral Agent and the Secured Parties have agreed to release their lien on all Pledged Collateral pledged pursuant to the Agreement.

A G R E E M E N T :

Collateral Agent hereby releases and terminates all right, title and interest pledged, hypothecated, assigned, transferred, deposited and granted to it by the Pledgors pursuant to the Agreement in all Pledged Collateral, including, without limitation, the Trademarks identified on Schedule I annexed hereto and any reissues, extensions and re-examinations thereof (collectively, the "Released Collateral"), and all liens, security interests, charges or other encumbrances in favor of Collateral Agent in the Released Collateral shall hereby terminate and revert to the Pledgors and all right, title and interest of Collateral Agent in the Released Collateral will hereby cease, terminate and become void.
