# GRANT FOR SECURITY

## (Trademarks)

WHEREAS, EQUITRAC CORPORATION, a Florida corporation (hereinafter referred to as "Assignor"), owns the trademarks listed on Schedule 1, annexed hereto and made a part hereof, which trademarks are registered, or the subject of pending applications for registration, in the United States Patent and Trademark Office (the "Trademarks"); and

WHEREAS, Assignor has entered into a Security Agreement dated as of August 6, 1999 (hereinafter the "Agreement") with, among others, certain of its subsidiaries and Fleet National Bank, as Administrative Agent thereunder (hereinafter referred to as "Assignee") for the "Secured Parties" identified therein, in order to secure the prompt and complete payment, observance and performance of the Secured Obligations, as defined in the Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor does hereby collaterally assign unto Assignee and grant to Assignee a security interest in, and mortgage on, all right, title, and interest of Assignor in and to the Trademarks, and the applications and registrations thereof, together with the goodwill of the business connected with the use of and symbolized by the Trademarks, including without limitation, any and all causes of action in conjunction therewith, and all proceeds thereof, including, without limitation, any and all royalties for any licenses thereof (the "Collateral"), to secure the prompt and complete payment, performance and observance of the Secured Obligations, as defined in the Agreement. Assignor does hereby further acknowledge and affirm that the rights and remedies of Assignee with respect to the assignment of the security interest in the Collateral made and granted hereby are more fully set forth in the Agreement, the terms and provisions of which are hereby incorporated by reference as if fully set forth herein.
