INSTRUMENT OF ASSIGNMENT AND ASSUMPTION

THIS ASSIGNMENT AND ASSUMPTION AGREEMENT (this "Assignment") is made as of February 25, 1998 ("Closing Date"), between IMPERIAL BANK ("Assignor") and OMAR KHUDARI ("Assignee"), pursuant to an ASSIGNMENT AND ACCEPTANCE AGREEMENT, dated as of June 18, 1997, by and between the Assignor and the Assignee (as amended, the "Agreement"). All capitalized terms used but not defined herein shall have the meanings given to such terms in the Agreement.

WHEREAS, the parties hereto desire by this Assignment for Assignor to assign to Assignee, and for Assignee to accept from Assignor, all of the rights and obligations of Assignor under those certain Loan Documents and other instruments listed on Annex I (collectively, the "Assigned Documents"), all upon the terms and subject to the conditions set forth in the Agreement and herein.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties hereto agree as follows:

Section 1. Assignment and Assumption. Subject to all the provisions of the Agreement, as of the Closing Date, Assignor hereby assigns to Assignee all of Assignor's rights, title and interest in and to the Assigned Documents (except for such rights, title and interest described in Section 6.9 of the Agreement), and Assignee hereby assumes from Assignor all of the commitments, duties and obligations of Assignor under the Assigned Documents.

Section 2. General.

2.1. Agreement Controlling. This Assignment is made, executed and delivered pursuant to the Agreement, and is subject to all the terms, provisions and conditions thereof. To the extent of any conflict between the terms of the Agreement and this Assignment, the Agreement shall be controlling. Assignor and Assignee expressly acknowledge and agree that neither the representations, warranties or covenants, nor the rights and remedies, of either party under the Agreement shall be deemed to be enlarged, modified or altered in any way by this Assignment.

2.2. Amendment. This Assignment may only be amended by an instrument executed and delivered by each party hereto.

2.3. Applicable Law. This Assignment shall be given effect and construed by application of the laws of the Commonwealth of Massachusetts.

2.4. Successors and Assigns. This Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns hereunder.
