**TRADEMARKS ASSIGNMENT**

This is an assignment by Fort James Corporation, a Virginia corporation ("Fort James") and Fort James Operating Company, a Virginia corporation ("FJOC," and together with Fort James, "Assignor") in favor of Graphic Packaging Corporation, a Delaware corporation ("Assignee"), to be effective as of August 2, 1999.

("ACX") are parties to an Asset Purchase Agreement dated as of April 25, 1999, providing for the sale by Fort James to ACX and Assignee of certain assets used in the Fort James packaging business, and for the assumption of certain liabilities specified therein (the "Asset Purchase Agreement");
