INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Intellectual Property Security Agreement dated September 29, 1999 is between SILICON VALLEY BANK ("Bank") and ECRIX CORPORATION, a Delaware corporation ("Grantor").

RECITALS

A. Bank will make advances to Grantor ("Loans") as described in the Loan and Security Agreement dated September 29, 1999, by and between Bank and Grantor (the "Loan Agreement"), but only if Grantor grants Bank a security interest in its Copyrights, Trademarks, Patents, and Mask Works.

B. Grantor has granted Bank a security interest in all of its right, title and interest, presently existing or later acquired to all the Collateral.

C. Capitalized terms used but not otherwise defined herein shall have the meanings ascribed in the Loan Agreement.

AGREEMENT

Grantor grants Bank a security interest in all of its right, title and interest in its Intellectual Property Collateral (such as the Copyrights, Patents, Trademarks and Mask Works listed on Schedules A, B, C, and D), and all proceeds (such as license royalties and proceeds of infringement suits), the right to sue for past, present and future infringements rights throughout the world and all re-issues, divisions continuations, renewals, extensions and continuations-in-part. As used herein, Intellectual Property Collateral shall not include any licenses or other agreements which by law or their terms may not be assigned by Grantor. Grantor represents and warrants to Bank that as of the date of this Agreement, Grantor holds no nonassignable licenses, except for the license granted in that certain Agreement dated February 4, 1999, by and between AIWA Co., Ltd., a Japanese corporation and Ecrix Corporation, a Delaware corporation. Grantor covenants to Bank to promptly notify Bank if Grantor shall be a party to a license that shall be assignable only with the consent of the other party thereto and to use its best efforts to obtain the consent of such other party if the Bank so requests.

This security interest is granted in conjunction with the security interest granted under the Loan Agreement. Bank's rights and remedies in the security interest are in addition to those in the Loan Agreement and the other Loan Documents, and those available in law or equity. Bank's rights powers and interests are cumulative with every right, power or remedy provided here. Bank's exercise its rights, powers or remedies in this Agreement, the Loan Agreement or any other Loan Document, does not preclude the simultaneous or later exercise of any or all other right, power or remedy.
