ASSIGNMENT OF UNITED STATES TRADEMARK REGISTRATION



WHEREAS, contemporaneously with the execution and delivery of this Agreement, Duke and Company have consummated the transactions contemplated by that certain Asset Purchase Agreement dated August 5, 1997, pursuant to which Duke has transferred certain of its assets to Company, including the Property listed on Exhibit A, for the consideration set forth therein.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Duke, by these presents, does hereby sell, assign and transfer unto Company all of its right, title and interest in and to the Trademark, together with the goodwill of the business symbolized by said Trademark, the same to be held and enjoyed by Company, for its own use and benefit and that of its successors and assigns, to the full end of the term for which said Trademark is granted, together with all claims for damages by reason of past infringement of said Trademark, with the right to sue for and collect the same for its own use and for the use of its successors, assigns or other legal representatives. Duke does hereby covenant and agree with said Company to execute and deliver such other and further instruments and take such other and further actions as may be reasonably necessary or appropriate to transfer said Trademark, claims for damages by reason of past infringement and right to sue and collect therefor to Company. Duke further warrants it has full right and title to and authority to assign the Trademark and it is free and clear of all liens and encumbrances of every kind.


