
TRADEMARK ASSIGNMENT

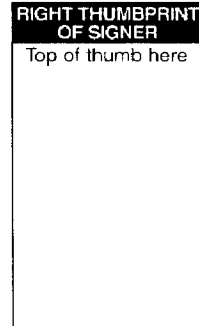
