**RELEASE OF TRADEMARK COLLATERAL ASSIGNMENT
AND
REASSIGNMENT OF TRADEMARK**

This Release of Trademark Collateral Assignment and Reassignment of Trademark is made as of August 18, 1999, between **FLEET CAPITAL CORPORATION**, a Rhode Island corporation ("Lender") and **RECOGNITION SYSTEMS, INC.**, a California corporation ("RSI").

WHEREAS, Harrow Products, Inc., a Delaware corporation ("Borrower") and Lender entered into a certain Loan and Security Agreement dated as of April 5, 1991, as amended (the "Loan Agreement"); and

WHEREAS, RSI guaranteed the obligations of Borrower to Lender pursuant to a Guaranty dated as of January 4, 1995 (the "Guaranty"); and


WHEREAS, the obligations of RSI to Lender under the Guaranty were secured, in part, by a Trademark Collateral Assignment and Security Agreement dated as of January 4, 1995, by and between RSI and Lender and recorded April 17, 1995 in the trademark records of the United States at Reel 1334, frame 0348; and

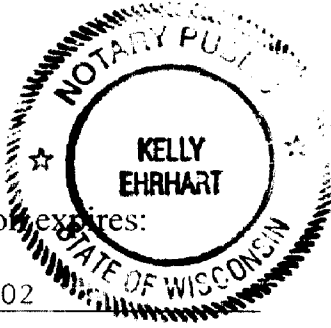
