**TRADEMARK RELEASE**

**THIS TRADEMARK RELEASE** is made this 29th day of October, 1999, by **FLEET CAPITAL CORPORATION** (the "Secured Party") in favor of **THE DUCANE COMPANY, INC.**, a South Carolina corporation (the "Grantor");

**W I T N E S S E T H:**

WHEREAS, on March 24, 1997, the Grantor and the Secured Party executed a Trademark Security Agreement (the "Security Agreement"), which was recorded on July 18, 1997 in Reel 1611, Frame 0122, Office of the Commissioner of Patents and Trademarks, pursuant to which the Grantor granted the Secured Party a lien in and security interest upon certain trademarks and trademark applications of the Grantor as more particularly described therein; and

This Trademark Release shall be binding upon the Secured Party and its successors and assigns.

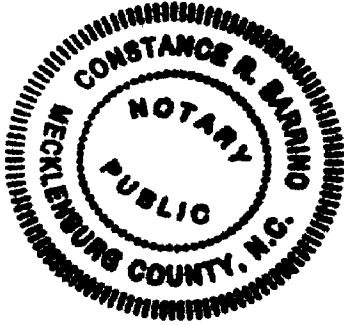
