RELEASE OF TRADEMARK SECURITY AGREEMENT

RELEASE, dated October 29, 1999 granted by Citicorp USA, Inc. ("Citicorp").

W I T N E S S E T H :

WHEREAS, AutoMed Technologies, Inc. ("AutoMed") and Citicorp, have entered into a Trademark Security Agreement, dated as of July 2, 1999, (the "Security Agreement"), pursuant to which AutoMed granted to Citicorp a security interest in all of the Trademarks and Licenses (as such terms are defined in the Security Agreement);

WHEREAS, the Security Agreement was filed with the United States Patent and Trademark Office on July 12, 1999 on Reel/Frame Number 001926/0292 with respect to the United States trademarks listed on Schedule A attached hereto and forming a part hereof (the "Scheduled Trademarks");

WHEREAS, AutoMed has requested Citicorp to release of record its liens upon the Scheduled Trademarks; and
