

# RELEASE AND REASSIGNMENT OF TRADEMARK

WHEREAS, EXCL Communications Inc., a Delaware corporation (the "Company"), owns the registered trademarks described in the attached Schedule A (the "Mark"), for which a recording is filed in the United States Patent and Trademark Office under the number set forth in the attached Schedule A; and




