TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Agreement") is made and entered into as of the date last below written by and between International Data Group, Inc. ("IDG" or "ASSIGNOR"), and internet.com Corporation, as successor in interest to internet.com LLC, as successor in interest to Internet World Media, Inc., and as successor in interest to Mecklermedia Corporation ("internet.com" or "ASSIGNEE").

WHEREAS, ASSIGNOR is the owner of the trademarks, service marks and any and all trade dress associated therewith as described in Exhibit 1 attached hereto ("the Marks"); and

all damages and payments for past or future infringements and misappropriations of the Marks; and

(5) all rights to sue for past, present, and future infringements or misappropriations of the Marks.

2. ASSIGNOR further conveys, transfers, assigns, delivers, and contributes to ASSIGNEE all rights in the trade dress, labels, and designs associated with the Marks.

3. ASSIGNOR covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in ASSIGNEE full right, title, and interest in the Marks worldwide.
