WHEREAS, DDG I, INC., GHI I, INC., OP II, INC., SUNBEAM AMERICAS HOLDINGS, LTD., SUNBEAM PRODUCTS, INC., LASER ACQUISITION CORP., COLEMAN WORLDWIDE CORP., SIGNATURE BRANDS INC., SIGNATURE BRANDS USA, INC., BRK BRANDS, INC., FIRST ALERT, INC., and SI II, INC. (herein referred to collectively as "**Grantors**", and each a "**Grantor**"), own, or in the case of licenses, are party to, the Trademark Collateral (as defined below);

WHEREAS, Sunbeam Corporation (the "**Parent**"), the Subsidiary Borrowers referred to therein, certain lenders (the "**Lenders**"), First Union National Bank, as Administrative Agent for the Lenders, Morgan Stanley Senior Funding, Inc., as Syndication Agent, and Bank of America National Trust and Savings Association, as Documentation Agent, are parties to a Credit Agreement dated as of March 30, 1998 (as the same may be further amended from time to time, the "**Credit Agreement**");

WHEREAS, the Parent is, or may hereafter become, obligated to one or more Lenders under one or more Hedging Agreements (as defined in the Credit Agreement) as contemplated by Section 5.10 of the Credit Agreement;

WHEREAS, pursuant to the terms of a Subsidiary Security Agreement dated as of July 10, 1998 (as such agreement may be further amended from time to time, the "**Subsidiary Security Agreement**") among Grantors and Morgan Stanley Senior Funding, Inc., as Administrative Agent for the Secured Parties (as defined in the Subsidiary Security Agreement) (in such capacity, together with its successors in such capacity, "**Grantee**"), Grantors have granted to Grantee for the benefit of the Secured Parties a continuing security interest in substantially all the assets of Grantors, including all right, title and interest of Grantors in, to and under the Trademark Collateral (as defined herein), whether now owned or

existing or hereafter acquired or arising, to secure the Secured Obligations (as defined in the Subsidiary Security Agreement);

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, in order to secure the full and punctual payment of the Secured Obligations in accordance with the terms thereof and to secure the performance of all the obligations of each Grantor hereunder and under the other Loan Documents, each Grantor hereby grants to the Administrative Agent for the ratable benefit of the Secured Parties, a continuing security interest in all of such Grantor's right, title and interest in and to all of the following (all of the following items or types of property being herein collectively referred to as the "**Trademark Collateral**"), whether now owned or existing or hereafter acquired or arising:

(i) each Trademark (as defined in the Subsidiary Security Agreement) owned by Grantors, including, without limitation, each Trademark registration and application referred to in Schedule 1 hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark;

(ii) each Trademark License (as defined in the Subsidiary Security Agreement), including, without limitation, each Trademark License identified in Schedule 1 hereto; and

(iii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by Grantors against third parties for past, present or future unfair competition with, or violation of intellectual property rights in connection with or injury to, or infringement or dilution of, any Trademark owned by Grantors, or for injury to the goodwill associated with any such Trademark, including, without limitation, any Trademark referred to in Schedule 1 hereto, and all rights and benefits of Grantors under any Trademark License, including, without limitation, any Trademark License identified in Schedule 1 hereto.

Each Grantor hereby irrevocably constitutes and appoints Grantee and any officer or agent thereof, with full power of substitution, as its true and lawful attorney-in-fact with full power and authority in the name of such Grantor or in its name, from time to time, in Grantee's discretion, so long as any Event of Default (as defined in the Credit Agreement) has occurred and is continuing, to take with respect to the Trademark Collateral any and all appropriate action which such Grantor might take with respect to the Trademark Collateral and to execute any and all documents and instruments which may be necessary or desirable to carry

out the terms of this Trademark Security Agreement and to accomplish the purposes hereof.

Except to the extent permitted in the Credit Agreement, each Grantor agrees not to sell, license, exchange, assign or otherwise transfer or dispose of, or grant any rights with respect to, or mortgage or otherwise encumber, any of the foregoing Trademark Collateral except for (i) licenses issued to contract manufacturers in the ordinary course of business and (ii) to the extent such activities would not adversely affect the value of the Trademark Collateral taken as a whole.

The foregoing security interest is granted in conjunction with the security interests granted to Grantee pursuant to the Subsidiary Security Agreement. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Grantee with respect to the security interest in the Trademark Collateral granted hereby are more fully set forth in the Subsidiary Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


