# ASSIGNMENT OF TRADEMARKS

MRS. WINNER'S, L.P.  
and  
WINNERS FRANCHISE SERVICES, LLC

TO

WINNERS INTERNATIONAL RESTAURANTS, INC.

Pursuant to the terms of the Contribution Agreement, dated as of the date hereof, by and among (i) WINNERS INTERNATIONAL RESTAURANTS, INC., a Delaware corporation (the "Buyer"); (ii) MRS. WINNER'S, L.P., a Georgia limited partnership ("Winners LP"); (iii) WINNERS FRANCHISE SERVICES, LLC, a Georgia limited liability company ("Winners LLC" and collectively with Winners LP, the "Contributors"); (iv) WINNERS CORPORATION, a Georgia corporation and (v) WINNERS PARTNERS, a Georgia general partnership (said Contribution Agreement being hereinafter referred to as the "Contribution Agreement"), in exchange for the consideration required to be delivered by the Buyer to the Contributors pursuant to the Contribution Agreement, the receipt and adequacy of such consideration being hereby acknowledged, the Contributors do hereby contribute to the Buyer's capital, transfer, assign and convey to the Buyer, effective as of the date hereof, the Trademark Rights (as such term is defined below), intending to convey all of the Contributors' right, title and interest therein.

1. "Trademark Rights" shall mean, collectively, all of the Contributors' trademark rights in trademarks relating to the Business, including, without limitation, those trademarks described on Schedule 1 attached hereto, and all other registration rights, applications for such rights, common law rights related thereto and all goodwill of the Business symbolized by such trademarks, and all claims, demands and rights of action which either Contributor has, or may have in the future, by reason of any infringement of the Trademark Rights being transferred pursuant to this Assignment of Trademarks (together with the right to prosecute such claims, demands or rights of action in such Contributor's own name), but excluding any of such claims, demands or rights of action arising or accruing prior to the Closing Date.

2. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed to them in the Contribution Agreement.

3. Notwithstanding anything expressed or implied in this Assignment and Bill of Sale to the contrary, the Buyer shall be entitled to designate a wholly-owned subsidiary of the Buyer as a recipient and titleholder of all or any portion of the Intangibles.

4. And for consideration aforesaid, the Contributors have covenanted and hereby do covenant with the Buyer, and its successors and assigns, that the Contributors and their successors and assigns will do, execute, acknowledge and deliver, or will cause to be done, executed, acknowledged and delivered, all such further acts, transfers, assignments and conveyances, powers of attorney and assurances for the better selling, transferring, assigning, assuring, conveying and confirming unto the Buyer, its successors and assigns, all and singular, the Trademark Rights or for aiding and assisting in collecting or reducing to possession any or all of the Trademark Rights, as the Buyer and its successors and assigns shall reasonably request.

5. Nothing in this Assignment of Trademarks shall be construed (i) as creating any representations or warranties by the Contributors other than those set forth in the Contribution Agreement, (ii) as limiting or terminating any representations, warranties or covenants of the Contributors contained in the Contribution Agreement or (iii) as providing for the sale, transfer, assignment or conveyance by the Contributors to the Buyer of any other assets of the Contributors described in Section 1.2 of the Contribution Agreement (the "Excluded Assets").


6. From and after the execution and delivery of this Assignment of Trademarks to the Buyer, the Contributors shall have no right, title and interest in the Trademark Rights.
