PARTIAL RELEASE OF TRADEMARKS


Secured Party shall execute any further documents as may be reasonably requested by Debtor in order to fully effectuate the release of its security interest in the Subject Trademarks.


This Release shall be governed in all respects by the laws of the State of California.
