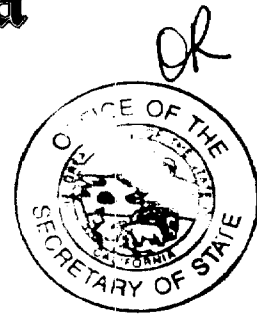

CERTIFICATE OF AMENDMENT
OF
ARTICLES OF INCORPORATION
OF
TUMBLEWEED SOFTWARE CORPORATION

Jeffrey C. Smith, President, and Joseph C. Consul, Chief Financial Officer, of Tumbleweed Software Corporation, a corporation duly organized and existing under the laws of the State of California do hereby certify:

1. That they are the duly elected and acting President and Chief Financial Officer, respectively, of Tumbleweed Software Corporation, a corporation duly organized and existing under the laws of the State of California (the "Corporation").
2. That an amendment (the "Amendment") to the Amended and Restated Articles of Incorporation of the Corporation (the "Articles") has been approved by the Board of Directors.
3. That the shareholders have adopted the Amendment by written consent. The Amendment was approved by the required vote of shareholders in accordance with Section 902 of the California Corporations Code. The total number of outstanding shares of capital stock of the Corporation is 16,985,487. The number of shares giving written consent in favor of said amendment exceeded a majority of the outstanding shares, which exceeded the minimum percentage vote required. A separate class vote of shares pursuant to Section 903 was not required to approve the Amendment.


4. That the Amendment approved by both the board of directors and the shareholders reads as follows:

Article First of the Articles is amended to read as follows:


FIRST: The name of the Company is Tumbleweed Communications Corp. (the "Company").
