ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT of intellectual property is dated February 117, 1999, from Stephan M. Rodolakis (the "Trustee"), the duly-appointed Chapter 7 Trustee of the bankruptcy estates of Indian Motocycle Company, Inc. ("Company"), Indian Motocycle Apparel and Accessories Co., Inc. ("Apparel"), and Indian Motocycle Manufacturing Company, Inc. ("Manufacturing"), and Sterling Consulting Corporation, a Colorado corporation as receiver (the "Receiver"), to IMCOA Licensing America, Inc. (the "Buyer"). The Trustee and the Receiver are collectively termed the "Sellers."

Recitals:

- a. The Debtors' Estates. On or about July 15, 1993, involuntary Chapter 7 Petitions were filed against Company and Apparel pursuant to Section 303(a) of the United States Bankruptcy Code. In a related case, Manufacturing filed a voluntary petition for relief under Chapter 11 of the United States Bankruptcy Code on February 15, 1994, and continued in possession of its property and continued to manage its affairs as a Debtor-in-Possession until October 23, 1995. On that date, its Chapter 11 proceeding was converted to a proceeding under Chapter 7 (Company, Apparel, and Manufacturing being collectively termed the "Chapter 7 Debtors"). The Chapter 7 Debtors' bankruptcy cases are pending before the United States Bankruptcy Court for the District of Massachusetts (the "Bankruptcy Court") in the actions captioned In Re: Indian Motocycle Company, Inc., In Re: Indian Motocycle Manufacturing Company, Inc., and In Re: Indian Motocycle Apparel Company, Inc., Case No.s 93-41354 -HJB, 94-42288-HJB, 93-41955-HJB, respectively.
- b. The Receivership Estate. The United States District Court for the District of Colorado (the "District Court") appointed Sterling Consulting Corporation the receiver of Indian Motorcycle Manufacturing, Inc. ("IMMI") on a temporary and permanent basis by orders dated April 10 and April 19, 1995, respectively. The receivership action is pending before the District Court in the action styled *Eller Industries, Inc. v. Indian Motorcycle Manufacturing, Inc.*, Civil Action No. 95-Z-777 (D. Colo.).
- c. The Combined Estates. As part of their respective duties, the Receiver and the Trustee have attempted to maximize the value of their estates (collectively, the estates of the Chapter 7 Debtors and the Receivership Estate are termed the "Combined Estates"). In furtherance of this goal, the Receiver and the Trustee agreed to sell their estates in coordinated fashion. On January 19, 1996, the Trustee and the Receiver filed their Coordinated Sale Agreement with the Bankruptcy Court for approval. The Coordinated Sale Agreement was approved by the Bankruptcy Court on January 19, 1996, and by the District Court on January 29, 1996, thereby putting the Coordinated Sale plan into effect.

- d. The Sale. (i) The Receiver, in connection with its authority under the Order Appointing Receiver, negotiated and executed a contract for the purchase and sale of the assets of the Combined Estates with IMCOA Licensing America, Inc.(the "IMCOA Agreement"). Responding to the Joint Motion to Approve Termination of Eller Contract, Set Contract Approval Procedure, and Approve Interim Funding of Receivership, filed October 18, 1998, the District Court approved the IMCOA Agreement by its Order dated December 7, 1998.
- (ii) The Trustee, in connection with his authority to collect and reduce to money the property of the estates pursuant to Bankruptcy Code §704, filed with the Bankruptcy Court the Motion for Order Authorizing Trustee to Sell all of the Debtor's (sic) Assets on or about December 12, 1998. In response to that Motion, the Bankruptcy Court approved the IMCOA Agreement by its Order Approving and Confirming Sale of Debtors' Assets, dated January 13, 1999.
- (iii) The IMCOA Agreement provides that the assets conveyed pursuant to its provisions shall be conveyed free and clear of all claims and encumbrances, including (inter alia) all "Liabilities" as such term is defined therein.

Sale Provisions

NOW, THEREFORE, in consideration of the foregoing Recitals, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and of the mutual covenants contained in the IMCOA Agreement, the Sellers hereby do the following:

- 1. Trustee's Transfer and Assignment. The Trustee hereby contributes, assigns, conveys, transfers, and delivers to the Buyer all of his right, title, and interest and the right, title, and interest of the Chapter 7 Debtors, in and to the trademark registrations and applications identified on Exhibit A attached hereto, including all goodwill appurtenant thereto. The Trustee hereby contributes, assigns, conveys, transfers, and delivers to the Buyer all of his right, title, and interest and the right, title, and interest of the Chapter 7 Debtors, in and to the common law trademark assets identified on Exhibit 1- B and 1- C attached hereto, including all goodwill appurtenant thereto. The foregoing grants shall include all rights under any claim of prior infringement or misappropriation of the trademarks which exist or may have existed prior to this conveyance.
- 2. Receiver's Transfer and Assignment. The Receiver hereby contributes, assigns, conveys, transfers, and delivers to the Buyer all of its right, title, and interest and the right,

title, and interest of the receivership in and to the trademark assets identified on Exhibit A, including all the goodwill appurtenant thereto. The Receiver hereby contributes, assigns, conveys, transfers, and delivers to the Buyer all of its right, title, and interest and the right, title, and interest of the Receivership Estate, in and to the common law trademark assets identified on Exhibit B attached hereto, including all goodwill appurtenant thereto (the interests transferred by the Trustee and the Receiver being collectively termed the "Property"). The foregoing grants shall include all rights under any claim of prior infringement or misappropriation of the trademarks which exist or may have existed prior to this conveyance.

3. Ancillary Assignment Documents. On behalf of the Trustee and the Receiver, the Receiver shall, upon the request of the Buyer and without further consideration, execute short form assignments in the appropriate form with respect to each of the trademark assets identified on Exhibit A. Further, either or both of the Trustee and the Receiver shall, upon the request of the Buyer and without further consideration or Court approval, execute such other documentation as may be necessary or convenient to record, effectuate, perfect or evidence the transfer, and to take such other action as Buyer may reasonably require to correct any alleged deficiencies in the chain of title or otherwise more effectively document, evidence, and give full effect to the provisions of this transfer. Without limiting the generality of the foregoing, on behalf of the Combined Estates, the Receiver shall, upon the request of the Buyer without further consideration or Court approval, execute "short form" assignments for each trademark application and each trademark registration in such form as the Buyer may request, including notarized execution, consular legalization by apostille or otherwise, as follows: (a) in connection with assignments of registrations and applications of trademark rights of record with the United States Patent and Trademark Office, the Receiver shall, upon the request of the Buyer without further consideration or Court approval, execute assignments substantially in the form attached hereto as Exhibit C; (b) in connection with assignments of registrations and applications of trademark rights of record with the various state trademark offices, the Receiver shall, upon the request of the Buyer without further consideration or Court approval, execute assignments substantially in the form attached hereto as Exhibit D unless one or more state trademark offices requires a different form and in such case shall execute such form other form as any such state trademark office may require for registration or filing in order to give effect to the substance of the conveyance contemplated by Exhibit D; (c) in connection with assignments of registrations and applications of trademark rights of record with the various trademark offices in foreign territories, the Receiver shall, upon the request of the Buyer without further consideration or Court approval, execute assignments substantially in the form attached hereto as Exhibit E or otherwise in such form as such foreign territories may require for registration or filing in order to give effect to the substance

of the conveyance contemplated by Exhibit E; and (d) in connection with assignments of common law trademark rights not reflected in the foregoing assignments, the Receiver shall, upon the request of the Buyer without further consideration or Court approval, execute assignments substantially in the form attached hereto as Exhibit F. Further assurances shall be provided upon request by the Trustee and/or Receiver or, following the conclusion of their respective Estates, the Clerk of Court or any other individual designated by the applicable Court shall without further consideration provide further assurances of the conveyance herein contemplated upon request by the Buyer.

- 4. Transfer Free and Clear of All Liens. Encumbrances and Interests. Pursuant to the Orders approving the IMCOA Agreement entered by the District Court and the Bankruptcy Court, the Sellers are transferring and conveying the Property to the Buyer free and clear of any liens, encumbrances, security interests, pledges, mortgages, charges, claims, Liabilities (as such term is defined in the IMCOA Agreement) or interests of whatever kind or nature. The scope, validity, force and effect of this transfer shall be determined solely by the respective orders of the Bankruptcy Court and the District Court, without any recourse being available to the Buyer against either of the Sellers.
- 5. <u>Effective Time</u>. The transfer of the Property pursuant to this Assignment shall be effective as of 12:01 a.m. on the <u>final</u> day of February, 1999.
