**Trademark Interests**

THIS FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS is granted by KEYBANK NATIONAL ASSOCIATION ("Secured Party"), a party to the Credit Agreement (as described below), having a place of business at Large Corporate Group, 700 Fifth Avenue, 46<sup>th</sup> floor, Seattle, Washington, 98104, in favor of ASSOCIATED VINTERS, INC., a Washington corporation ("Grantor"), having a place of business at 14030 N.E. 145<sup>TH</sup> Street, Woodinville, Washington 98072.

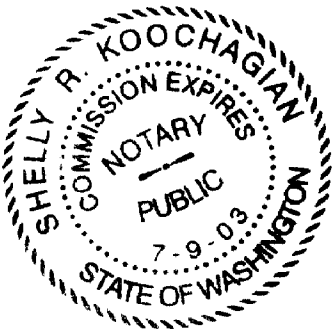
