

WHEREAS, RVSI has requested that the Secured Party release and reassign its interest in the Trademarks.


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Party hereby:

2. Authorizes and requests the United States Patent and Trademark Office to note and record the existence of the release hereby given.


