**RELEASE AND REASSIGNMENT**

This **RELEASE AND REASSIGNMENT** is granted on this 14<sup>th</sup> day of April, 2000 by Imperial Bank, a California chartered bank with a place of business at 11512 El Camino Real, Suite 350, San Diego, California 92130 ("**Assignor**"), as the Secured Party under the Credit Agreement, dated as of June 10, 1999 (the "**Credit Agreement**"), in favor of People Mover, Inc., a Delaware corporation with a place of business at 1500 Rosecrans Avenue, Suite 310, Manhattan Beach, California 90266 ("**Assignee**").

**WHEREAS**, in connection with the Credit Agreement, dated as of June 10, 1999, Assignee has executed and delivered to Assignor an Intellectual Property Security Agreement, dated as of June 19, 1999 (the "**Security Agreement**"), granting Assignor a security interest in all of Assignor's Intellectual Property Collateral (as such term is defined in the Security Agreement) including, but not limited to all the Trademarks listed on Exhibit A thereto, and all files and records relating to Intellectual Property Collateral, and the proceeds thereof, whether owned at the time of execution or thereafter acquired; and

**WHEREAS**, the Security Agreement was recorded in the United States Patent and Trademark Office on June 25, 1999, at Reel 1920/Frame 0236 et. seq.; and

**WHEREAS**, Assignor has discharged Assignee from the Indebtedness (as defined in the Credit Agreement) and all other obligations set forth in the Credit Agreement and the Security Agreement;

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Assignor hereby terminates and releases its security interest in and lien upon the Intellectual Property Collateral, including but not limited to the Trademarks set forth in Exhibit A hereto, and reassigns to Assignee any and all right, title, and interest in the Intellectual Property Collateral previously assigned to it by Assignee.
