



DISCHARGE OF REVOLVING CREDIT AND SECURITY AGREEMENT-TRADEMARKS/PATENTS

On September 29, 1998 Liberty Optical, Inc., a Delaware corporation and Carmine S. DiChiara executed a certain Rider to Revolving Credit and Security Agreement-Trademarks/Patents (the "Security Agreement") in favor of PNC Bank National Association ("PNC").

The Security Agreement was executed concurrently with a Revolving Credit and Security Agreement (the "Credit Agreement") whereby PNC agreed to loan money to Liberty (the "Loan").
