TRADEMARK ASSIGNMENT

Assignor shall promptly prepare and deliver for recording (at Assignee's request and expense) any instrument necessary to perfect or record the transfer of any of the trademark registrations in the United States Patent and Trademark Office, and any other recording office in a foreign country where such recordings are properly made. Without limiting the foregoing, Assignee will be responsible for any legal expenses or government fees associated with recording any assignment or other instrument necessary to perfect or record the transfer of any of the trademark registrations in the U.S. and in any foreign countries.

Upon the Assignee's request at any time and from time to time, Assignor shall execute and deliver to the Assignee, at Assignee's expense, such additional instruments as are reasonably necessary to vest the Assignee with the sole ownership of all such trademark registrations.


Due to the parties' geographic locations, the parties have agreed that signatures for execution of this Trademark Assignment and any certificate, instrument, or other document entered into and/or delivered pursuant to or in connection with this Trademark Assignment may be provided by facsimile; and upon receipt of such facsimile signature, the party accepting such signature shall be entitled to rely on the execution thereof, and such signature will be binding and effective as if the original counterpart had been transmitted and/or delivered.




