**RELEASE OF SECURITY AGREEMENT**

This Release of Security Agreement dated as of May 18, 2000, made by WELLS FARGO BUSINESS CREDIT, INC., a Minnesota corporation, ("Secured Party") to Organic Food Products, Inc., a California corporation, with its business address at 1304 South Point Boulevard, Petaluma, California 94954 ("Debtor").
