Vickers, Incorporated, a corporation organized and existing under the laws of Delaware,

DOES HEREBY CERTIFY:

**FIRST:** That this corporation was incorporated on the 22nd of March, 1963, pursuant to the General Corporation Law of the State of Delaware.

**SECOND:** That this corporation owns all of the outstanding shares (of each class) of the stock of Vickers E.S.D., Inc., a corporation incorporated on the 22nd day of November, 1995, pursuant to the General Corporation Law of the State of Delaware.

**THIRD:** That this corporation, by the following resolutions of its Board of Directors, duly adopted by the unanimous consent of its members, filed with the minutes of the Board, on the 13th day of December, 1996, determined to and did merge into itself said Vickers E.S.D., Inc.:

"RESOLVED, that Vickers, Incorporated merge, and it hereby does merge, into itself Vickers E.S.D., Inc. and assumes all its obligations; and

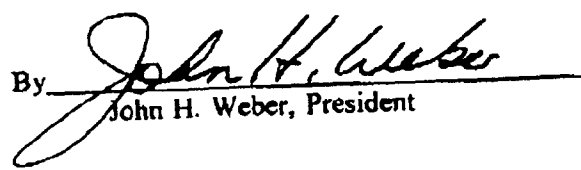
"RESOLVED FURTHER, that the merger shall become effective at the start of business on January 1, 1997; and
