RELEASE OF SECURITY AGREEMENT

This Release of Security Agreement dated as of May 19, 2000, made by FINOVA Capital Corporation, a Delaware corporation, ("Lendor") to Organic Food Products, Inc., a California corporation, with its business address at 1304 South Point Boulevard, Petaluma, California 94954 ("Grantor").

WHEREAS, Grantor and Lendor entered into a Trademark Security Agreement ("Agreement") which were secured by, inter alia, the granting by Borrower to Grantor of a security interest in certain Trademarks of the Borrower (collectively "the Collateral"), to secure the obligations of Grantor under the Loan Agreement, and

WHEREAS, the Security Agreement dated October 9, 1998 was recorded in the U. S. Patent and Trademark Office on October 16, 1998, and is located on Reel 1801 at Frame 502; and

WHEREAS, the amount of the Loan Agreement has been repaid in full and the Lendor intends to release its security interest in the Collateral;
