PARTIAL RELEASE OF SECURITY INTEREST

WHEREAS, Xionics Document Technologies, Inc., a Delaware corporation, with a principal place of business at 70 Blanchard Road, Burlington, MA 01803 (the "Company") granted to Fleet Bank of Massachusetts, N.A. ("Fleet-Mass") a security interest in certain of its trademarks, as evidenced by a Notice of Security Interest in Trademarks dated September 27, 1995 from the Company to Fleet-Mass (the "1995 Trademark Notice"), the 1995 Trademark Notice having been filed with the Patent and Trademark Office on October 5, 1995, Reel 1399, Frame 774; and

WHEREAS, Fleet National Bank (the "Bank") has succeeded by merger to the rights of Fleet-Mass; and

WHEREAS, the Company also granted to the Bank a security interest in certain of its trademarks as evidenced by a Notice of Security Interest in Trademarks dated January 14, 1998 from the Company to the Bank (the "1998 Trademark Notice"), the 1998 Trademark Notice having been filed with the Patent and Trademark Office on February 2, 1998, Reel 1685, Frame 379; and

WHEREAS, the Bank wishes to release from its security interest the three trademarks described below;

NOW, THEREFORE, the Bank agrees as follows:

1. The Bank hereby releases from its security interest the following trademarks (the "Released Trademarks"):

XIP DRIVER - Reg. No. 2,067,415, registered June 3, 1997 (application no. 74/403,158)


XIP PRINT - Reg. No. 1,931,971, registered October 31, 1995 (application no. 74/403,150)

XIP VIEW - Reg. No. 1,924,462, registered October 3, 1995 (application no. 74/403,196)

2. Each of the 1995 Trademark Notice and the 1998 Trademark Notice is hereby amended by deleting therefrom any references to the Released Trademarks.

3. Except for the release of the Released Trademarks, the Bank's security interest and its rights under each of the 1995 Trademark Notice and the 1998 Trademark Notice remain in full force and effect as heretofore.
