TRADEMARK PURCHASE AND TRANSFER

This Trademark Purchase (the "**Purchase**"), is entered into as of 5:30 pm Hong Kong Standard Time on the 12th day of November, 1999, by and between Akai Musical Instrument Corporation, a Texas corporation having an address at 4710 Mercantile Drive, Fort Worth, Texas 76161, USA (the "**Purchaser**"), and Akai Electric Co., Ltd., a Japanese joint stock company having an address at 11-5, Shin-yokohama 2-Chome, Kohoku-ku, Yokohama, 222-0033 Japan (the "**Seller**").

WITNESSETH:

WHEREAS, Seller, through its Electronic Musical Instrument Division, is engaged in the business of researching, designing, manufacturing, marketing and selling a variety of equipment, software and peripheral devices for use in working with music and voice and satellite transmitted data in electronic form, including without limitation products involved with the creation, acquisition, production, presentation and archiving of audio, video and data content utilized by professionals, government entities, and hobbyists for the purpose of commercial audio, video and data content creation and presentation, which products include without limitation all of the products marketed under the following marks: AKAI DIGITAL; AKAI PROFESSIONAL; the DPS, DL, MT, AMX, DD, DV, DDX, DR, DP, RC, CD, RE, ASR, GCF, EWI, S and MPC product series names; SHRED-O-MATIC; INTELLIPHASE; HEADRUSH; VARIWAH; TUNE LOCK; REMIX; SUPERVIEW; MESA; and HALF THE CALORIES ALL THE PHAT (collectively, the "**EMI Business**");

WHEREAS, Seller acknowledges that Purchaser is acquiring under this Purchase all of the EMI Business trademarks, trade names, business and product names, logos and trade dress rights, and all of the goodwill associated with any of the foregoing, used by Seller in connection with the EMI Business, including worldwide rights to the trademark AKAI but only in connection with the EMI Business, and including without limitation those trademarks, trademark registrations and trademark applications listed on attached Schedule 1 (collectively, the "**EMI Business Trademarks**");

WHEREAS, Purchaser acknowledges that Seller is retaining ownership of the worldwide trademark rights to the trademark AKAI for use in connection with Seller's non-EMI Businesses (but not the combined marks AKAI PROFESSIONAL or AKAI DIGITAL), such as Seller's non-commercial, consumer-level, home and mobile entertainment products; and

WHEREAS, Purchaser is desirous of acquiring the EMI Business Trademarks and all other rights owned by Seller in the EMI Business Trademarks.

NOW, THEREFORE, in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which hereby acknowledged, Seller assigns to Purchaser and its successors and assigns the entire right, title, and interest, throughout the world, in

and to the EMI Business Trademarks (which does NOT include any rights to the trademark AKAI for use in connection with Seller's non-EMI Businesses), and all renewals, substitutions, and extensions thereof, including the right to sue for and collect damages for past infringement. Seller authorizes and requests the official of any country or countries whose duty it is to issue trademark registrations on applications as aforesaid, to issue all registrations issuing therefrom to Purchaser, and each party shall, upon request of the other, execute a letter for filing with national trademark offices worldwide consenting to the registration of the AKAI mark by the other party for its respective goods and services.

Seller shall deliver to Purchaser all files in its possession or in possession of its agents concerning the EMI Business Trademarks, including all trademark prosecution and enforcement files.

Seller covenants that it has the full right to convey the entire right, title, and interest in and to the EMI Business Trademarks and the rights herein assigned, and that it has not executed, and will not execute, any agreement in conflict herewith. Seller further covenants and agrees that it will sign all lawful papers, make all rightful declarations and/or oaths and generally do what is necessary to enable Purchaser, its successors, legal representatives and assigns, to record and enforce this Purchase and properly protect and enforce the EMI Business Trademarks in all countries. Moreover, as the parties acknowledge that the attached Schedule 1 fails to list some of the trademarks and registrations and applications therefor being sold and transferred hereunder, Seller covenants that it will cooperate with Purchaser to create the complete list and then sign all lawful papers, make all rightful declarations and/or oaths and generally do what is necessary to enable Purchaser, its successors, legal representatives and assigns, to vest record title of such registrations and applications in the name of Purchaser. The parties shall cooperate to prevent any confusion caused by their simultaneous use of the AKAI mark.

IN WITNESS WHEREOF the parties hereto have executed this Purchase as of the date set forth above by their duly authorized representatives.


