WHEREAS, Constar International, Inc., a Delaware corporation with a place of business at One Central Plaza, 835 Georgia Avenue, Chattanooga, Tennessee 37402 ("CONSTAR") had adopted, used and was the owner of the mark **C and Design**, registered with the United States Patent and Trademark Office as Registration No. 1,775,893, which issued on June 8, 1993.


