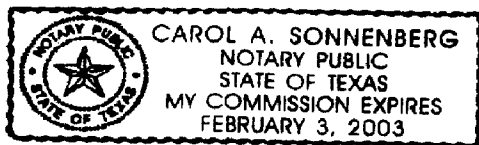
WHEREAS, Assignee wishes to acquire all right, title, and interest in and to the Mark, including the registration thereof, together with the goodwill symbolized by the Mark;


