THIS AGREEMENT is made as of the 15 day of June, 1999 between F.G.G. INVESTMENTS, INC., a corporation organized under the laws of Delaware, whose principal place of business is 500 George Washington Highway, Smithfield, R.I. (the "Assignor") and COTTET S.A., a French company, which address is: Les Buclets, B.P. No. 4 - Morbier - 38400 Morez, France (the "Assignee") with reference to the following facts:

WHEREAS, Assignor is the owner of the Trademark Registrations for the mark "REBELS" in International class 009, for eye glasses and sun glasses, as set forth on the attached schedule (Exhibit A).

WHEREAS, Assignor wishes to assign the Trademark Registrations and all the appurtenant rights and interest herein to Assignee and Assignee wishes to accept such assignment.

NOW, THEREFORE, IN CONSIDERATION of the mutual covenants and undertakings hereinafter set forth, the parties have agreed as follows:

1. **Assignment**

In consideration for the sum of thirty thousand dollars (\$30,000.00) paid by Assignee to Assignor, Assignor, who is the owner of all rights, title and interest in and to the Trademark Registrations for the mark "REBELS" shall assign and transfer to Assignee, all of Assignor's rights, title and interest in and to the Trademark Registrations, and all goodwill of the business in the goods for which the mark is registered.

2. **Goodwill**

It is understood that, in addition to the Trademark, as part of this transaction and included in the price stated in Article 1 above, Assignor shall sell and transfer to Assignee the goodwill associated with the Trademark and with the business in the products sold under such Trademark.

3. **Delivery and Registration of Assignment**

Assignor shall execute and deliver to Assignee one valid assignment for each registration of the Trademark, as applicable, and any other documents necessary for the valid recordation of such assignment with the Patent and Trademark Office. Assignor shall send such assignment to Assignee via overnight mail or courier, within two (2) days of receipt of a check for \$30,000. Each of the parties shall execute such further documents and other papers and perform such further acts as may be reasonably required or desirable to carry out such assignments, including, if necessary any documents pertaining to the releases of certain security interests in the Trademark Registrations pre-dating this Agreement.

4. Entire Agreement



5. Governing Law


