TRADEMARK SECURITY AGREEMENT

TRADEMARK SECURITY AGREEMENT, dated as of June 30, 2000, by FastWeb, Inc., a Delaware corporation (the "*Borrower*"), in favor of LaSalle Bank National Association (the "*Lender*").

WITNESSETH:

WHEREAS, pursuant to the Loan Agreement, dated as of June 30, 2000 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "*Loan Agreement*") between the Borrower and the Lender, the Lender has agreed to make an extension of credit to the Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, the Borrower is party to a Security Agreement of even date herewith in favor of the Lender (the "*Security Agreement*") pursuant to which the Borrower is required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lender to enter into the Loan Agreement and to induce the Lender to make an extension of credit to the Borrower thereunder, the Borrower hereby agrees with the Lender as follows:

Section 1. Defined Terms. Unless otherwise defined herein, terms defined in the Loan Agreement or in the Security Agreement and used herein have the meaning given to them in the Loan Agreement or the Security Agreement.

Section 2. Grant of Security Interest in Trademark Collateral. The Borrower, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Liabilities of the Borrower, hereby grants to the Lender a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of the Borrower, except such Collateral that constitutes Excluded Property (the "*Trademark Collateral*"):

all of its Trademarks and Trademark Licenses to which it is a party referred to on *Schedule I* hereto;

all reissues, continuations or extensions of the foregoing;

all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

all Proceeds of the foregoing, including any claim by the Borrower against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.


Section 3. Security Agreement. The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Lender pursuant to the Security Agreement and the Borrower hereby acknowledges and affirms that the rights and remedies of the Lender with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

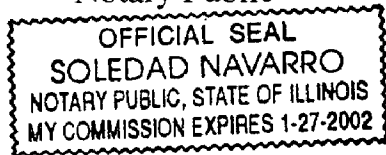
