ASSIGNMENT OF TRADEMARKS

with which the Marks are used and for which they are registered; (2) the right to conduct business under the Marks, including the right to license others to use and conduct business under the Marks; (3) the business of the Assignor, or portion thereof, to which the Marks pertain; (4) the right to collect all damages and payments for past or future infringements and misappropriations of the Marks; and (5) all rights to sue for past, present and future infringements or misappropriations of the Marks.

Assignor further conveys, transfers, assigns, delivers, and contributes to Assignee all rights in the trade dress, labels and designs associated with the Marks.

This Assignment is effective as of the date hereof. Assignor agrees to sign and/or have its appropriate affiliate sign any additional assignments and other appropriate documentation necessary to effectuate and validate this Assignment as soon as is practicable after the date of this Assignment.

Assignor covenants that it will execute all documents, papers, forms, and authorizations and take all other actions that may be necessary for securing, completing, or vesting in Assignee full right, title, and interest in the Marks worldwide.
