Accordingly, the Collateral Agent hereby releases its security interest in the trademark registrations and trademark applications covered by the Security Agreement, including but not limited to those U.S. trademark registrations and applications listed on Schedule A attached hereto. Collateral Agent agrees that it will execute all such further documents as may be reasonably requested by Jason to carry out the transactions contemplated hereunder.

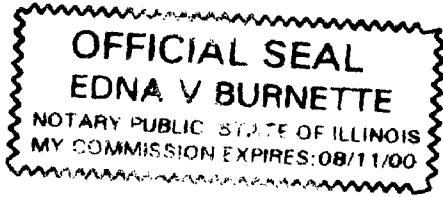
