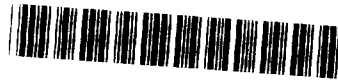

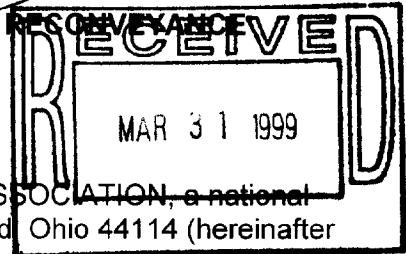

THIS AGREEMENT, by and between KEYBANK NATIONAL ASSOCIATION, a national banking association having an address at 127 Public Square, Cleveland, Ohio 44114 (hereinafter "KeyBank") and RANPAK CORP., an Ohio corporation having a place a business at 7990 Auburn Road, Painesville, Ohio 44077 (hereinafter "Ranpak"), shall be effective the 21st day of October, 1998.

WHEREAS, KeyBank and Ranpak entered into a security agreement in which certain trademarks of Ranpak, listed on Schedule A attached hereto ("Trademarks"), became subject to a security interest set forth in a Security Agreement dated August 20, 1996 and recorded at Reel 1498, Frame 0326 in the United States Patent and Trademark Office;

WHEREAS, Ranpak has requested, and KeyBank has agreed, that KeyBank release its security interest in certain property to be sold by Ranpak; and

WHEREAS, KeyBank hereby releases KeyBank's security interest in the Trademarks.

NOW, THEREFORE, in consideration of the premises, and for other good and valuable consideration, the receipt thereof being hereby acknowledged, the parties agree as follows:

1. KeyBank hereby releases its security interest in and to the Trademarks.
2. To the extent any residual claims, ownership or interests remain with KeyBank in the Trademarks, KeyBank hereby assigns, transfers, and conveys all right, title and interest in and to the Trademarks, to Ranpak.
3. The release of security interest set forth in this agreement shall not be construed to waive or in any matter affect or invalidate the Security Agreement dated August 20, 1996 with respect to any intellectual property described therein, other than the Trademarks.

IN WITNESS WHEREOF, KeyBank, by its duly authorized representative, hereby signs this Agreement as of the date and year first written above.
