WHEREAS, Curwood, Inc. will continue the business of producing, selling, and distributing specialty plastic films.



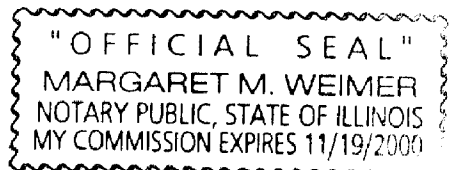
