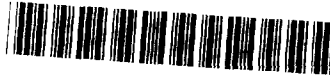

**RELEASE OF GRANT OF SECURITY INTEREST  
IN CERTAIN INTELLECTUAL PROPERTY**

Capitalized terms used and not otherwise defined herein have the meanings ascribed to them in the Secured Term Loan Agreement, dated as of December 8, 1998, between Carson Products Company, a Delaware corporation (the "Borrower"), Carson, Inc., a Delaware corporation ("Holdings"), the lenders party thereto (the "Lenders"), Wells Fargo Bank Minnesota, NA. (formerly known as Norwest Bank Minnesota, N.A.), as successor administrative agent (the "Administrative Agent"), and Wells Fargo Bank Minnesota, N.A. (formerly known as Norwest Bank Minnesota, N.A.), as collateral agent (the "Collateral Agent") (as modified, supplemented and amended to the date hereof, the "Loan Agreement"), pursuant to which certain term loans were made to the Borrower.

This Release of Grant of Security Interest in Certain Intellectual Property (this "Release") is made and entered into this 10th day of October, 2000 by and between the Borrower and the Collateral Agent.

**W I T N E S S E T H :**

WHEREAS, the Borrower and the Collateral Agent are parties to the Borrower Intellectual Property Security Agreement dated as of December 8, 1998 (the "IP Security Agreement");

WHEREAS, the Collateral Agent holds a security interest in specific intellectual property owned by the Borrower as set forth in Schedule A annexed hereto (the "Intellectual Property");

WHEREAS, simultaneously with the execution of a Termination, Release and Indemnification Agreement dated as of August 11, 2000 (the "Termination Agreement"), the Borrower has repaid, and the Administrative Agent has accepted the repayment of, all Term Loans and all other amounts outstanding under the Loan Agreement, the Term Notes and the other Credit Documents and to terminate all Commitments under the Loan Agreement: and

WHEREAS, in consideration of the repayment by the Borrower of all Term Loans and all other amounts outstanding under the Loan Agreement, the Term Notes and the other Credit Documents pursuant to the Termination Agreement, the Borrower has requested that the Collateral Agent release all of the Collateral Agent's security interests in the Intellectual Property, and the Collateral Agent has agreed to do so.

NOW THEREFORE, in consideration of the foregoing, the parties to this Release, intending to be legally bound, agree as follows:

1. The Collateral Agent hereby releases in its entirety its security interest in all of the Borrower's right, title, and interest in, to and under the Intellectual Property, and the Collateral Agent hereby agrees, at the expense of the Borrower, to take any actions and to execute any further documents necessary or reasonably requested by the Borrower to effectuate or evidence such release, including, but not limited to, the execution and delivery of those documents necessary under Article 9 of the Uniform Commercial Code or other applicable law.

2. The parties hereto authorize and request the Commissioner of Patents and Trademarks of the United States to record this Release against the Intellectual Property.

3. This Release shall be governed by and construed in accordance with the laws of the State of New York.

4. This Release may not be modified, nor may any provision hereof be waived, orally or in any manner other than by an agreement in writing signed by the parties hereto or their respective successors and assigns.


