RELEASE OF SECURITY INTEREST IN UNITED STATES TRADEMARKS

THIS RELEASE is granted by Foothill Capital Corporation (hereinafter referred to as "Foothill"), to BKN, Inc. (f/k/a Bohbot Entertainment and Media, Inc.), a Delaware corporation (hereinafter referred to as the "Debtor").

WHEREAS, Debtor and Foothill entered into a Loan and Security Agreement dated as of September 30, 1998 (as amended, the "Loan Agreement"), and a related Trademark Security Agreement dated as of September 30, 1998 (hereinafter referred to as the "Security Agreement") by which Foothill acquired security interests in, to and under the Trademark Collateral (as defined in the Security Agreement), including (but not limited to) the Trademarks (as defined in the Security Agreement) listed on Schedule A attached hereto, to secure the satisfactory performance and payment of all of the Secured Obligations (as defined in the Security Agreement);
