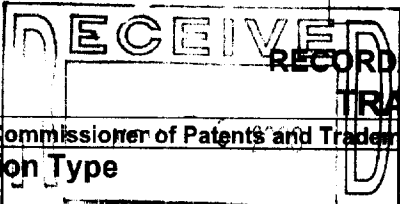

It is hereby certified that:

1. The constituent business corporations participating in the merger herein certified are:

(i) Mosaix, Inc. ("Mosaix"), which is incorporated under the laws of the State of Washington; and

(ii) Avaya Inc. ("Avaya"), which is incorporated under the laws of the State of Delaware.

2. A Plan and Agreement of Merger has been approved, adopted, certified, executed, and acknowledged by each of the aforesaid constituent corporations in accordance with the provisions of subsection (c) of Section 252 of the General Corporation Law of the State of Delaware, to wit, by Mosaix in accordance with the laws of the State of its incorporation and by Avaya in the same manner as is provided in Section 251 of the General Corporation Law of the State of Delaware.

3. The name of the surviving corporation in the merger herein certified is Avaya Inc., which will continue its existence as said surviving corporation under its present name upon the effective date of said merger pursuant to the provisions of the General Corporation Law of the State of Delaware.

4. The Certificate of Incorporation of Avaya, as now in force and effect, shall continue to be the Certificate of Incorporation of said surviving corporation until amended and changed pursuant to the provisions of the General Corporation Law of the State of Delaware.

5. The executed Plan and Agreement of Merger between the aforesaid constituent corporations is on file at an office of the aforesaid surviving corporation, the address of which is 211 Mt. Airy Road, Basking Ridge, New Jersey 07920.

6. A copy of the aforesaid Plan and Agreement of Merger will be furnished by the aforesaid surviving corporation, on request, and without cost, to any stockholder of each of the aforesaid constituent corporations.

7. The Plan and Agreement of Merger between the aforesaid constituent corporations provides that the merger herein certified shall be effective on September 29, 2000.


8. The authorized capital stock of Mosaix consists of 1,000 shares without par value and shall, at the effective time of the merger, be surrendered and extinguished.
