RELEASE AND REASSIGNMENT

THIS RELEASE AND REASSIGNMENT, dated as of May 24, 1991, is made by The First National Bank of Chicago, as Collateral Trustee under the Credit Agreement described below, having offices at One First National Plaza, Chicago, Illinois 60670 (the "Trustee").

WHEREAS, Kenner Parker Toys Inc., a Delaware corporation, having offices at 50 Dunham Road, Beverly, Massachusetts 01915, ("Kenner Parker"), entered into a Credit Agreement with the Trustee, the banks which are parties thereto and The First National Bank of Chicago (as one of such Banks and) as Agent, dated as of October 13, 1987 (the "Loan Agreement"), pursuant to which Kenner Parker incurred certain Secured Obligations (as defined in the Loan Agreement); and

WHEREAS, as security for performance by the Company of the Secured Obligations, Kenner Parker entered into a Collateral Patent, Trademark, Copyright and License Security Agreement and Assignment with the Trustee dated as of October 13, 1987 (the "Security Agreement") pursuant to which Kenner Parker granted to the Trustee a security interest in its patents, patent applications, trademarks, trademark applications, trade names, goodwill, copyrights and proprietary rights licenses as described therein (collectively, the "Collateral"); and

WHEREAS, the Security Agreement was recorded with the United States Patent and Trademark Office on January 7, 1988, on the Patent Assignment records on Reel 5271, Frames 001-101 and on the Trademark Assignment records on Reel 0701, Frames 001-107 (a copy of which is attached hereto as Exhibit I) and was recorded with the U.S. Copyright Office on January 3, 1988, Volume 2426, Pages 67-167 (a copy of which is attached as Exhibit II); and

WHEREAS, subsequent to the execution and delivery of the Loan Agreement and the Security Agreement, on July 5, 1988 Kenner Parker merged with and into Tonka Corporation, a Minnesota corporation, having offices at Interchange North Building, 300 South Highway 169, St. Louis Park, Minnesota 55426-1112 (the "Company") and, as a result of this merger the Company became the owner, by operation of law, of all of Kenner Parker's rights, title and interest in and to the Collateral and became the successor-in-interest to the Company;

WHEREAS, substantially all of the Secured Obligations have been paid or otherwise satisfied and the Company and the Trustee have agreed to terminate the Security Agreement and the Trustee has agreed to release its security interests in and to the

Collateral and to reassign to the Company any and all right, title and interest the Trustee has in and to the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. The Trustee hereby releases its security interest in, and hereby reassigns, transfers and conveys to the Company, all right, title and interest which the Trustee has, if any, in and to the Collateral, such Collateral being described as follows:

(i) all patents and patent applications, including, without limitation, the inventions and improvements described and claimed therein, those patents listed on Schedule A, attached hereto and made a part hereof, and any reissues, divisions, continuations and continuations-in-part thereof (the "Patents"), and (a) all income, and/or royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (b) all rights to sue for past, present and future infringements thereof, and (c) all rights corresponding thereto throughout the world;

(ii) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos, other source or business identifiers, prints and labels on which any of the foregoing have appeared or appear, designs and general intangibles of like nature, trademark registrations and applications for registration, now owned or hereafter acquired by the Companies, including, without limitation, the trademarks and applications listed on Schedule B, attached hereto and made a part hereof, together with the goodwill of the business connected with the use of, and symbolized by, the foregoing, and all renewals thereof (the "Trademarks"), and (a) all income, royalties, damages and payments now or hereafter due or payable with respect thereto, including, without limitation, damages and payments for past or future infringements thereof, (b) all rights to sue for past, present and future infringements thereof, and (c) all rights corresponding thereto throughout the world;

(iii) copyrights, registered or unregistered statutory or common law, in and to the works set forth in Schedule C attached hereto and made a part hereof, including all registrations and applications therefor and all rights to sue and recover for past infringement thereof and any renewals or extensions of the registrations therefor that may be secured

under the laws now or hereafter in effect in the United States or any other country or countries, and all license agreements covering the Copyrights, and all proceeds therefrom (individually or collectively referred to as the "Copyrights"); and

(iv) license agreements whether covering Patents, Trademarks or Copyrights with any other party authorizing sales, manufacturing or use within the United States, whether the Companies are licensors or licensees under any such license agreements, including, without limitation, the licenses listed on Schedule D, attached hereto and made a part hereof.

2. Pursuant to paragraph 8 of the Security Agreement, the Trustee agrees that it will execute such further documents as may be reasonably requested by the Company to release the security interest created by the Security Agreement and to reassign to the Company all of the Trustee's interest, if any, in and to the Collateral.

3. This Release and Reassignment is delivered to the Company and is for the benefit of the Company and its successors and assigns.

4. This Release and Reassignment terminates Security Agreement in its entirety and the Trustee and successors and assigns shall hereafter have no claim, right or interest in and to the Collateral under the Security Agreement.

IN WITNESS WHEREOF, the Trustee has caused this Release and Reassignment to be duly executed by its duly authorized officer as of the day and year first above written.

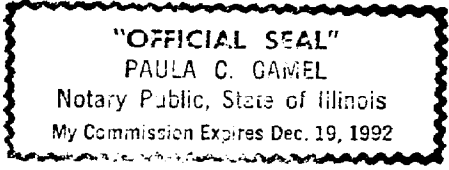
