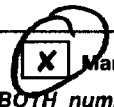

**RELEASE AND REASSIGNMENT**  
**(Trademarks and Tradenames)**

THIS RELEASE AND REASSIGNMENT ("Release") is made as of February 21, 2001, by **U.S. Bank National Association**, a national banking association ("Lender"). Capitalized terms used but not otherwise defined herein shall have the respective meanings ascribed in the Security Agreements referenced below.

**W I T N E S S E T H :**

WHEREAS, Lender and **Michaels of Oregon Co.**, an Oregon corporation whose address is 1710 Red Soils Court, Oregon City, Oregon 97045 ("Borrower") are parties to a certain Trademark Security Agreement in United States Trademarks dated June 30, 1999, and a certain Security Agreement dated June 30, 1999 (together, the "Security Agreements"), pursuant to which Borrower has granted a security interest to Lender in and a collateral assignment to Lender of, among other things, the Released Trademarks ( as defined below); and

WHEREAS, the Released Trademarks were recorded in the United States Patent and Trademark Office on **September 5, 2000**, in the Assignment Division at **Reel 002144 Frame 0113**; and

WHEREAS, Borrower and its affiliates have satisfied the Secured Obligations in full and Borrower has requested that Lender release its security interest in the Released Trademarks and reassign the same to Borrower;

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:


1. Lender hereby releases its security interest in all of Borrower's right, title and interest in and to all of the following assets (all of which being hereinafter referred to as the "Released Trademarks"):

The United States trademarks and trademark applications set forth on attached Schedule I; the goodwill associated therewith; all renewals thereof; all rights to income, royalties, profits, awards, damages or other rights relating thereto, including, without limitation, the right to sue for past, present or future infringement; all licenses and agreements, written or oral, providing for the grant by or to Borrower of any right to use any trademark; and all proceeds thereof.

2. Lender hereby reassigns, grants and conveys to Borrower without any representation, recourse or undertaking by Lender, all of Lender's right, title and interest in and to the Released Trademarks.
