RELEASE OF SECURITY INTEREST (TRADEMARKS)

WHEREAS, LIGHT & SOUND DESIGN HOLDINGS LIMITED (“LSDHL”), LIGHT & SOUND DESIGN LIMITED (“LSDL”) and LIGHT & SOUND DESIGN, INC. 2. Authorizes and requests the United States Patent and Trademark Office to note and record the existence of the release hereby given.


