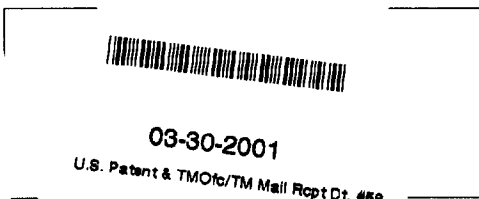

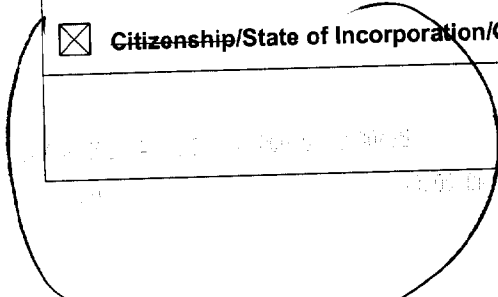

TRADEMARK ASSIGNMENT
