ASSIGNMENT OF TRADEMARKS

THIS ASSIGNMENT is made as of March 12, 2001, by BANK OF AMERICA, N.A. (formerly known as Bank of America National Trust and Savings Association), as agent ("Assignor"), for the benefit of THE MEAD CORPORATION, an Ohio corporation ("Assignee"), under the following circumstances:

A. Pursuant to a Collateral Turnover Agreement (the "Turnover Agreement") dated February 27, 2001, among Pen-Tab Industries, Inc. ("Pen-Tab"), Pen-Tab Holdings, Inc. ("Holdings"), Stuart Hall Company, Inc. ("Stuart Hall" and, with Pen-Tab and Holdings, the "Companies") and Assignor, the Companies surrendered to Assignor possession of substantially all of their personal property including, without limitation, certain registered trademarks and the associated goodwill.

B. Assignee and Assignor have entered into an Asset Purchase Agreement of even date herewith (the "Purchase Agreement") pursuant to which Assignee is purchasing from Assignor all of the right, title and interest of the Companies in certain of the assets they surrendered to Assignor pursuant to the Turnover Agreement (the "Purchased Assets"). Terms defined in the Purchase Agreement and not otherwise defined herein are used herein with the meanings given to them in the Purchase Agreement.

C. Assignor is entering into this Agreement pursuant to Section 6.02(b) of the Purchase Agreement to assign to Assignee all of the right, title and interest of the Companies in the trademarks included in the Purchased Assets.

NOW, THEREFORE, FOR VALUE RECEIVED, the undersigned, hereby sells, assigns, conveys, and transfers all of the right, title and interest of the Companies and the Assignor in the registered trademarks described on Exhibit A attached hereto, including the associated goodwill (the "Trademarks").

Assignor shall take such other actions and shall execute and deliver such other instruments, agreements and documents as Assignee reasonably may request in order to effectively transfer, (and without expanding in any manner whatsoever the provisions of or the obligations of the Assignor under the Purchase Agreement), all of the Companies' right, title and interest in and to the Trademarks to Assignee.

This instrument is subject to all of the terms and conditions of the Purchase Agreement, and shall be governed by, and enforced in accordance with, the laws of the State of Illinois without regard to the principles of conflicts of laws thereof. Consistent with, but not in limitation of, the foregoing, Assignor has made and makes no representation or warranty as to title transfer shall result in said assets being transferred free and clear of any security interest or liens asserted by Assignor.
