FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS

Trademark Interests

THIS FULL RELEASE AND RECONVEYANCE OF SECURITY INTERESTS is granted by CREDIT SUISSE FIRST BOSTON, as agent (in such capacity herein called, "Agent") for various banks under the Amended and Restated Credit Agreement dated as of December 8, 1999 (as amended or modified, the "*Credit Agreement*") in favor of DATEK ONLINE HOLDINGS CORP.
