

GRANT OF SECURITY INTEREST (TRADEMARKS)

CANAD, INC., a New Hampshire corporation (the "Guarantor"), is obligated to THE BANK OF NEW YORK, as Administrative Agent (the "Administrative Agent"), and has entered into the Second Amended and Restated Security Agreement, dated as of February 9, 2001 (as the same may be amended, supplemented or otherwise modified, the "Agreement"), with the Administrative Agent.

Pursuant to the Agreement, the Guarantor granted to the Administrative Agent a security interest in all of the right, title and interest of the Guarantor in and to all trademarks listed on Schedule I attached hereto, which trademarks are registered in the United States Patent and Trademark Office (the "Trademarks"), together with the goodwill of the business associated with or symbolized by the Trademarks, all registrations and recordings thereof, all registration applications thereof, and all proceeds thereof, including past, present or future infringement or dilution of any Trademark now or hereafter owned by the Guarantor or injury to the goodwill associated with or symbolized by any Trademark now or hereafter owned by the Guarantor (the "Collateral"), to secure the prompt payment, performance and observance of its Obligations (as defined in the Agreement).

For good and valuable consideration, the receipt of which is hereby acknowledged, and for the purpose of recording the grant of the security interest as aforesaid, the Guarantor does hereby grant to the Administrative Agent a security interest in the Collateral to secure the prompt payment, performance and observance of the Obligations.

The Guarantor does hereby further acknowledge and affirm that the rights and remedies of the Administrative Agent with respect to the security interest in the Collateral made and granted hereby are set forth in the Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein.

Upon the indefeasible cash payment in full of all Obligations, the Administrative Agent will take whatever actions are necessary at the Guarantor's expense to release or reconvey to Guarantor all right, title and interest of the Guarantor in and to the Trademarks.
