ASSIGNMENT OF TRADEMARK AND RELATED APPLICATION BASED ON INTENT-TO-USE

This Assignment is made and effective as of the 1st day of January, 2001, by and between SmartForce ("SmartForce"), a Delaware company with offices located at 900 Chesapeake Drive, Redwood City, CA 94063 and NCS Pearson, Inc. ("NCS Pearson"), a Minnesota corporation with its principal offices at 11000 Prairie Lakes Drive, Eden Prairie, MN 55344; and

WHEREAS National Computer Systems, Inc. filed an application for registration for the trademark, "RealSkills" ("the Mark") based upon a bona fide intent to use, the details of which are set out below; and

WHEREAS National Computer Systems, Inc. changed its name to NCS Pearson, Inc. effective November 1, 2000; and

WHEREAS, NCS Pearson owns and has a bona fide intent to use the Mark in connection with the following goods and/or services: a) Computer software programs for the training, test registration, testing, test delivery in the field of information technology and instruction manuals sold as a unit; b) Job placement services for interns and employees; c) Educational services, namely, training, test registration and educational testing, for candidate seeking certification in the field of information technology; d) Testing to determine employment skills; preparing, administering and scoring of standardized tests to determine employment skills; and

WHEREAS, NCS Pearson has applied to register the Mark on the Principal Register of the United States Patent and Trademark Office based on NCS Pearson's bona fide intent to use the mark in commerce in connection with the above-described goods and/or services, Application Serial No. 75543994 filed on August 31, 1998; and

WHEREAS, SmartForce desire to acquire the business of NCS Pearson in connection with which NCS Pearson has a bona fide intent to use the Mark and the pending Application; and

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, NCS Pearson does hereby sell, assign and transfer to SmartForce all NCS Pearson's right, title and interest in and to the Mark and the pending Application therefore, together with NCS Pearson's business in connection with which it has a bona fide intent to use the Mark, said assignment to be effective as of the date first written above. A copy of the Application as filed, and the Notice of Allowance containing the current description of goods for the Application are attached to this Assignment as Exhibit A.
