

ASSIGNMENT OF PROPRIETARY RIGHTS

THIS ASSIGNMENT OF PROPRIETARY RIGHTS ("ASSIGNMENT"), made as of this 6th day of June, 2001, is by and among EnviroChem Technologies, L.L.C. (the "Assignor") and The Sherwin-Williams Company (the "Assignee").

WITNESSETH:

WHEREAS, Assignor, Assignee, Mobile Enterprises, Inc. and John F. Unsworth have entered into a Purchase Agreement, dated of even date herewith ("Agreement"); and

WHEREAS, Assignor is the sole and exclusive owner of all right, title and interest in and to all names (including but not limited to "EnviroChem"), patents, patent applications, inventions, marks, formulas (patented and unpatented), symbols, trade names, trademarks, service marks, trade secrets, technical know-how, methods, operations, copyrights, copyright applications, logos, franchises, software, processes (patented and unpatented), process instructions, permits, licenses and sublicenses (and agreements in respect thereof or applications therefor), patent, trademark and copyright prosecution histories, laboratory notebooks, outside testing data, power point presentations, computer files concerning any training or technical data or information, and all other proprietary rights, documents, information and records related to the Business (as defined in the Agreement) or the Products (as defined in the Agreement) including, but not limited to, all filings, registrations or issuances of any of the foregoing with or by any federal, state, local or foreign regulatory, administrative or governmental office or offices, and all federal, state and common law rights protecting such in the United States of America and throughout the world, including, but not limited to, those listed on Schedule A, which is attached hereto and made a part hereof ("Proprietary Rights"); and

WHEREAS, Assignee desires to acquire ownership of the Proprietary Rights and Assignor is willing to convey to Assignee all of its entire right, title and interest in and to the Proprietary Rights; and

NOW, THEREFORE, for the consideration recited in the Agreement, the receipt and sufficiency of which is hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Assignor hereby sells, assigns, transfers and delivers to Assignee its entire right, title and interest in and to the Proprietary Rights.
2. Upon Assignee's request, Assignor will execute any and all instruments necessary to effectuate the intent of Section 1 hereof in order to confirm and secure the assignment of Assignor's entire right, title and interest in and to the Proprietary Rights.
3. Upon Assignee's request, Assignor shall transfer to Assignee all existing documents and files available to or in its possession which relate to the Proprietary Rights.
