INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT

This INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT (the "Agreement"), dated as of July 1, 1999, is entered by and between AMERICAN NATIONAL CAN COMPANY, a Delaware corporation, having a place of business at 8770 W. Bryn Mawr Avenue, Chicago, Illinois ("ANC"), and PECHINEY PLASTIC PACKAGING, INC., a Delaware corporation, having a place of business at 8770 W. Bryn Mawr Avenue, Chicago, Illinois ("Pechiney Plastics").

WHEREAS, ANC and Pechiney Plastics have entered into a Contribution, Assignment and Assumption Agreement, dated as of July 1, 1999 (the "Contribution Agreement");

WHEREAS, the Contribution Agreement requires ANC and Pechiney Plastics to execute and deliver this Agreement;

NOW, THEREFORE, in consideration of the premises and mutual agreements and covenants set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

SECTION 1. Definitions. As used in this Agreement, the following terms shall have the meanings set forth below.

"Patents" means the patents and patent applications set forth on Schedule A, all reissues, divisions, continuations, continuations-in-part, extensions and reexaminations thereof, and all rights therein provided by international treaties or conventions.

"Trademarks" means the trademarks and service marks set forth on Schedule B, the goodwill of the business symbolized thereby, all common law rights with respect thereto, all applications and registrations thereof, all rights therein provided by international treaties or conventions, and all extensions and renewals thereof.

SECTION 2. Transfer and Assignment of Intellectual Property. ANC hereby sells, assigns, and transfers to Pechiney Plastics all of its right, title and interest in and to the Patents, Trademarks, and the goodwill of the business symbolized by the Trademarks.

SECTION 3. Governmental Filings. ANC shall furnish Pechiney Plastics with such necessary information and reasonable assistance, including execution of such other required

documents, as Pechiney Plastics may reasonably request in connection with recording its ownership interest in the Patents and Trademarks, with any governmental authority.

SECTION 4. Construction. The parties agree that, to the extent that any terms or provisions of this Agreement differ or conflict with any provision or term of the Contribution Agreement, the applicable terms and provisions of the Contribution Agreement shall control and take precedence.

SECTION 5. Governing Law. This Agreement shall be governed by, and construed in accordance with, the laws of the State of Illinois, United States of America, without giving effect to the conflicts of law principles thereof.

SECTION 6. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed to be an original but all of which taken together shall constitute one and the same instrument.






