SECOND AMENDED AND RESTATED ARTICLES OF INCORPORATION,
AS AMENDED TO DATE, OF
MEDI-JECT CORPORATION**

1. The name of this corporation is Medi-Ject Corporation, a Minnesota corporation (the "Company").
