- (2) DELPHI TECHNOLOGIES INC whose principal place of business is at 5725 Delphi Drive, Troy, Michigan 48098 – 2815 USA (the "Purchaser")

WHEREAS:-

Lucas is the proprietor of the Non UK trade marks and the Non UK trade mark applications brief particulars of which are set out in Schedule 1 hereto (the "Trade Marks" and the "Applications" respectively) and has agreed to assign the same to the Purchaser.

IT IS AGREED AS FOLLOWS:-

1. DEFINITIONS

In this Assignment Agreement the following terms have the meanings set out beside them:-

"the Applications" means the Non UK trade mark applications short particulars of which are set out in Schedule 1 hereto;

now paid by the Purchaser to Lucas (the receipt of which Lucas hereby acknowledges) Lucas **HEREBY ASSIGNS** and transfers to the Purchaser with full title guarantee all of its property, right, title and interest in and to the Trade Marks and the Applications and all its rights, powers, privileges and immunities conferred, arising or accruing therefrom subject to the licences referred to in Schedule 2 hereto and together with the right to sue for damages and other remedies in respect of any infringements or other violations which may have occurred prior to the date hereof in

respect of the Trade Marks and/or the Applications **TO HOLD** unto the Purchaser absolutely.

3. Lucas will at the request and expense of the Purchaser do all acts and execute all documents and procure the deposing to or swearing of any declarations or oaths reasonably necessary or desirable for vesting absolutely all right, title and interest in and to the Trade Marks and the Applications in favour of the Purchaser and for conferring on the Purchaser rights of action in relation to any infringement of the Trade Marks and/or the Applications by third parties at or prior to the date hereof and pending the doing executing and making of such acts, documents, declarations, oaths and things Lucas shall hold the legal estate in the Trade Marks and the Applications in trust for the Purchaser.
4. Lucas agrees, at the request of the Purchaser, to transfer to the Purchaser Lucas' files and records (including those in the possession of its agents) relating to the filing prosecutions and maintenance of the Trade Marks and the Applications.
5. This Assignment Agreement is governed by and shall be construed in accordance with the laws of England.
6. This Assignment Agreement may be signed in counterparts.
